### Year R Building:

Walk to the field playground and assemble on the tarmac area.

### **Main Building:**

Assemble on the main playground.

Once assembled a head count will be carried out and everyone will wait in their assembly point for further instructions Do not return to the building until you are instructed to do so.

### **Disabled Visitors**


If you are disabled and feel that you may require assistance during the evacuation of the building, please advise Reception staff when signing in.
